
Wuerker Is Honored For Service To Agriculture As Board Term Ends

A native of Saxony, Ger many, Wuerker grew up on his father's 120 acre dairy grain and crops farm. After graduatiag from a special ized agricutural high school he worked as an apprentice and later as assistant farm manager on a 3,000 acre farm owned by the Baron Von Bismark where, as Wuerker puts it, they "grew everything." He came to the United States in 1929 and worked on farms in Wisconsin and Colorado before settling in Cape May County.
